- (i) Civil Engineering (Total intake:60)

- (iii) Electrical Engineering (Total intake: 30)
- (iv) Food Processing Technology (Total intake: 30)
- (v) Mechanical Engineering (Total intake: 30)
- 50% of the approved intake is to be filled up through JEXPO-2018 Examination conducted by WBSCT&VE&SD, Kolkata for the candidates of West Bengal
- Remaining 50% of the approved intake is to be filled up through GKCIET Entrance Test (GET) 2018 conducted by Ghani Khan Choudhury Institute of Engineering & Technology (GKCIET), Malda for the candidates from other states excluding West Bengal.

Prescribed Medical Standards for Admission

• The candidate should possess good health and physique with sound mind. He / she should not be suffering from any disease, physical or mental infirmity.

Allowable Defects in Eyesight

- Myopia or Myopic Astigmatism: Total strength of correcting lens not exceeding 3.5 Dioptre and acuteness of vision after correction (a) 6/9 in one eye and (b) 6/6 in another.
- Hyper-metropia not exceeding 14 Dioptre or Hypermetropic Astigmatism: Strength of correcting lens not exceeding 4 Dioptre and acuteness of vision after correction (a) 6/9 in one eye and (b) 6/6 in another.
- The candidates should not be colour blind
