# **Notification/Guidelines**

Admission in Diploma Programs through JEXPO & VOCLET Counseling/Provisional Admission for the A. Y. of 2022-23

### All Candidates.

Greetings from Ghani Khan Choudhury Institute of Engineering and Technology, Malda — a Centrally Funded Technical Institute (CFTI) established under the Ministry of Education, Govt. of India! In this Academic Year of 2022-23, our Institute is offering AICTE approved Diploma programs (3 years duration) in (i) **Civil Engineering**, (ii) **Computer Science & Technology**, (iii) **Electrical Engineering**, (iv) **Food Processing Technology** and (v) **Mechanical Engineering** affiliated to West Bengal State Council of Technical & Vocational Education and Skill Development (WBSCT&VE&SD), Kolkata.

#### The admission criteria are:

For candidates taking admission in 1st Year:

- Candidates must pass Madhyamik Examination from West Bengal Board of Secondary Education or its equivalent Board/Council with English, Mathematics and Physical Science/Science/Science and Technology amongst others as subjects and secure at least 35% marks (no rounding off) in aggregate without additional. Conforming to the benchmark of 35% marks (no rounding off) in aggregate is a must, failing which candidature will be cancelled even after allotment of a seat.
- The candidate should not be born after 01.07.2007 and there is no upper age limit.

### For candidates taking admission in 2nd Year:

- Students passing 12th Class with Vocational / Technical subjects or 10th + (2 years ITI). ITI candidates must possess original marksheet or pass certificate at the time of Admission.
- Passed / Appeared\* 10+2 examination with Physics and Chemistry as compulsory subjects along with Mathematics or Biology from any recognized Board/ Council/ Institute
- There is no age limit.

## (2) Payment of Fees (for 1st Semester Only)

Only after successful verification of all documents by department faculties, an admission/registration fee (1st Semester Fee)of Rs. 1205/- (Rs. 905/- for TFW candidates), in addition to the seat booking fee of Rs. 500/- paid to the State Council, is to be paid in a single transaction for admission. Fee Structure for Diploma programs of 3 years duration is enclosed as Annexure-VIII. (Any excess fee collected may be adjusted later)

### (3) Confirmation of your provisional admission (Diploma in A. Y. of 2022-23)

After receiving the receipt, UTR No. and Transaction ID of your online payment, concerned officers/Finance Section will check respective payment status. On successful payment only, concerned departmental officers will confirm your provisional admission in Diploma program of this Institute.

### (4) Submission of hard copies of necessary documents

Submit hard copy of the application with all originals as per Sl. No. 1 (i, iv, xi, xvii, xvii, xix) and self-attested Xerox copies for other necessary documents and **one xerox copy of the whole set** during physical admission as per WBSCTE&VE&SD counseling schedule. Your final admission will be confirmed only after receiving all of the necessary/required documents as per the Institute / affiliating Council.

### (5) Hostel Facility

**Hostel rooms are not guaranteed.** However, the Institute at its own discretion may allot hostel rooms to the students once mess facilities are ready. An amount of Rs. 6,000/- per semester per student (mess charges extra) will be collected as room rent when hostels become operational.
