## NOTIFICATION OF ROUND 1 DECENTRALIZED COUNSELLING FOR LATERAL ENTRY/ADMISSION IN THE VACANT SEATS OF B. TECH PROGRAMS

With reference to the Notification issued by the Department of Higher Education, Govt. of West Bengal vide No. 372/10M-51/15 dated 18.10.2022 and with approval of the Competent Authority of Ghani Khan Choudhury Institute of Engineering and Technology (GKCIET), the Institute would like to invite applications from all the interested candidates for appearing in the decentralized counselling for lateral entry in the vacant seats of B. Tech programs. The Institute is presently offering B. Tech programs in (1) Electrical Engineering, (2) Food Technology and (3) Mechanical Engineering affiliated to Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal.
