Please also note the following:

As per the WBUT Act XV of 2000, Chapter VIII, Classe 3.(e) & 3.(f)

- Number of vacancies in a Branch shall be decided on the basis that the final effect of change in the "gainer" branch shall not exceed the total number of students in the said branch by more than 10% of the sanctioned intake for the branch.
- Number of students of a branch allowed to change their branches shall be regulated such way that the final effect of change in the "loser" branch shall not fall below 10% of the existing strength of students prior to the change of branch.
