- a) Student must have minimum 8.5 YGPA
- b) Student must have cleared all papers in 1st attempt.
- c) Gainer branch should not gain more than 10% of its intake capacity while loser branch should not lose more than 10% of its current strength (rounded off to its lower integer).
- d) Institutional decision is final and binding.

- 2. Rank card of WBJEE/JoSAA/CSAB

It is further to be notified that the selection has to be made as per the <u>University Regulation i.e.</u> considering the YGPA 8.5 and above. In case of tie among students, selection has to be made on the basis of the rank of the student in West Bengal Joint Entrance Examination.

Please note that YGPA of a student can be referred from the results available in colleges' account in exam portal for branch change decision OR can be calculated using following formula:

YGPA (Yearly Grade Point Average) Credit Index Odd Semester + Credit Index Even Semester

2 Credits Odd Semester + 2 Credits Even Semester
