Notification of decentralized counselling Round 2 for JEE Main rank holders for admission in vacant seats of B. Tech programs in A.Y. 2026-27

The Institute would like to conduct decentralized admission only for JEE Main rank holders for admission in the vacant seats of B. Tech programs in A.Y. 2026-27. The Institute offers B. Tech programs in (1) Civil & Environmental Engineering, (2) Computer Science and Engineering (AI & ML), (3) Electrical Engineering, (4) Food Technology and (5) Mechanical Engineering.

- Allotment and reservations in all of the above vacant seats will be done following Govt. orders, strictly based on merit. For admission to the decentralized counselling Round 2, a candidate should have a valid JEE-Main rank and fulfil the following criteria:
- The admission criteria are:**
 - Secured a rank in JEE Main-2026.
 - Candidate/s must have a pass in Class XII examination in 2024/2025/2026 with individual pass marks in both Theory and Practical.

- (c) Must have obtained at least 45% marks (40% in case of candidates belonging to reserved category i.e. SC, ST, OBC-A, OBC-B, PwD) taken together in three subjects mentioned earlier.
- (d) Minimum 30% marks in English in Class X+2 as per affiliating university rules.
- (e) Lower age limit is 17 (seventeen) years as of 31.12.2026. A candidate should have been born on/before 31.12.2009.
- The candidates must visit the Academic Office physically on **02-09-2026 on/before 1:00 PM** with relevant documents. Tokens will be issued till 1:00 PM; then Merit List will be prepared as per JEE-Mains CRL Ranks. Finally, admissions will be as per the eligibility criteria in accordance with JEE-Mains 2026 /JoSAA/CSAB/ affiliating University norms.
