# Notification/Guidelines Admission/Registration in Diploma Programs through JEXPO & VOCLET Counseling/Provisional Admission for Academic Year of 2020-21

## All Candidates,

Greetings from Ghani Khan Choudhury Institute of Engineering and Technology, Malda-a Centrally Funded Technical Institute (CFTI) established under the Ministry of Education, Govt. of India! In this Academic Year of 2020-21, our Institute is offering AICTE approved Diploma programs (3 years duration) in (i)**Civil Engineering**,(ii)**Computer Science & Technology**,(iii)**Electrical Engineering**, (iv) **Food Processing Technology** and (v) **Mechanical Engineering** affiliated to West Bengal State Council of Technical & Vocational Education and Skill Development (WBSCT&VE&SD), Kolkata.

The admission criteria are:

For candidates taking admission in 1st Year:

- Candidates must pass Madhyamik Examination from West Bengal Board of Secondary Education or its equivalent Board/Council with English, Physical Science/Science and Mathematics amongst others as subjects and secure at least 35% marks (no rounding off) in aggregate without additional. Conforming to the benchmark of 35% marks (no rounding off) in aggregate, is a must, failing which candidature will be cancelled even after allotment of a seat.
- The candidate should not be born after 01.07.2005 and there is no upper age limit.

For candidates taking admission in 2nd Year:

- Candidates must pass H.S. (Vocational) from West Bengal State Council of Technical & Vocational Education & Skill Development or pass Xth + (2 years ITI). Candidates passed H.S. (Vocational) from other Council or appearing in ITI during 2020 are not eligible.
- There is no age limit.

## (2) Verification of all documents after receiving through e-mails

After receiving all required documents from each candidate in referred email (<u>siraj@gkciet.ac.in</u>)/above e-mail ids of respective departments, the concerned departmental officers will contact with the candidate/parents over telephone,

WhatsAppChat/Video Calling or other digital video mode for verification of all documents. During verification, all original documents are to be shown by the candidate and concerned officers are also to be satisfied with your documents. Thereby, all candidates are requested to keep ready all above required documents serially before the verification. Your verification schedule, verification report and any declaration on your documents as per requirement/institute norms will be informed by the concerned departmental officials.

# (3) Payment of Fees (for 1<sup>st</sup> Semester Only)

Only after successful verification of all documents, an admission/registration fee (1<sup>st</sup> Semester Fee)of **Rs. 1205/- (Rs. 905/- for TFW candidates), in addition to the seat booking fee of Rs. 500/- paid to the State Council,** is to be paid for admission. Fee Structure for Diploma programs of 3 years duration is enclosed as **Annexure-IX**. (*Any excess fee collected may be adjusted later*)

#### (5) Submission of hard copies of necessary documents

Send hard copy of the application with all originals as per Sl. No. 2(i, iv, xi, xvii, xiii, xix, xx) and self attested Xerox copies for other necessary documents as per the section (2),

and *one xerox copy of the whole set* by speed post to *OSD (Acad.& Exam)/Academic Coordinator, Academic Section, Ghani Khan Choudhury Institute of Engineering and Technology, Narayapur, Malda, West Bengal-732141* or by physically in the office/Academic Section of our Institute by post/ after pandemic as per the affiliating Council/before registration under the affiliating Council. Your final admission will be confirmed only after receiving all of the necessary/required documents as per the Institute / affiliating Council.

### (6) Hostel Facility

The hostel facility inside campus of the Institute is under construction and hence, Institute is unable to provide such facility at present. However, it will be available after the completion of construction in due course of time. It is likely to take at least one year. In case of female students, a 50 seated hostel facility is available, that to be allotted 'First Come First Served' basis.
