Sub: Guidelines regarding conduct of practical classes for the 2nd and 3rd year diploma students in the academic session 2020-21

Sir/Madam,

You are already aware that practical classes for the 2nd and 3rd year diploma students will be conducted on and from **18.02.2021** (Thursday). An order regarding this matter issued by the Director of Technical Education & Training, Govt. of WB, has already been mailed for your information and taking necessary action. Top priority while conduct in practical classes should be safety, health and well-being of the students, teachers and staff. In this regard, following guidelines are furnished below for the convenience of all concerned for conduct of practical classes for the 2nd and 3rd year diploma students in the academic session 2020-21 with strict compliance of COVID-19 safety protocols.

- Physical distancing should be maintained at all places and crowding must not be allowed at any place inside the campus under any circumstances.
- ii) Depending on the availability of space in practical class rooms/ laboratories or learning sites, up to 50% students may be allowed on a rotation basis to attend the classes and necessary guidelines/protocols to prevent the spread of COVID-19 should be observed.
- iii) Institutes should consider reducing the class size and break them in multiple sections to maintain physical distancing during the classes. At all times, the teachers and students should maintain a physical distancing of 6 feet apart, wherever feasible. Institutes should plan accordingly so that all the students may participate in the practical classes on a rotation basis.
- iv) While permitting, outdoor spaces may be utilized for conducting teacher student interactions, keeping in view the safety and security of students and physical distancing protocols.
- v) The practical class rooms/laboratories are to be sanitized after conducting the classes for each batch.
- vi) Wearing of face cover/ mask by all students and staff should be ensured.

- vii) Institutes should provide hand sanitizers at the laboratories for their students. The students may also be advised to carry their own sanitizers.
- viii) Hand washing stations with facilities of liquid soap should be created so that every student can wash his/her hands frequently.
- ix) All teachers who are at higher risk, i.e., older teachers and the teachers who have underlying medical conditions are advised to take extra precautions. They should preferably not be exposed to any front-line work requiring direct contact with the students.
- x) Institutes should make the students aware of the COVID-19 related situation, precautions and steps to be taken to stay safe and healthy.

Principals/Officers-in-Charge are requested to adopt the aforesaid guidelines and take necessary steps to implement them accordingly for conduct of practical classes for 2^{nd} and 3^{rd} year diploma students.
