NOTIFICATION OF DECENTRALIZED COUNSELLING FOR ADMISSION IN THE VACANT SEATS OF 4-YEAR B. TECH PROGRAMS

With reference to the Notification issued by the Department of Higher Education, Govt. of West Bengal vide No. 391-Edu (T)/10M-86/15 dated 03.11.2022 and with approval of the Competent Authority of Ghani Khan Choudhury Institute of Engineering and Technology (GKCIET), the Institute would like to invite applications from all the interested candidates for appearing in the decentralized counselling for vacant seats of B. Tech in following programs: (1) Electrical Engineering, (2) Food Technology, (3) Mechanical Engineering. All these programs are affiliated to Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal.

Candidates who are already admitted in GKCIET through WBJEE-2022 will not be eligible to participate.
