Agenda Item No. BoG 16.03: To consider and confirm the minutes of the 12th FCmeeting held at MHRD, Shastri Bhawan, New Delhi on 21.10.2019

Resolution: Approved with a slight modification in the item no. FC 12.03. Now, the resolutions reads:

"After a brief discussion, FC noted the minutes of the 10th meeting of B&WC. Further, FC advised GKCIET that for proposed construction of new hostel, an itemised proposal may be brought in the next FC. Further, it was resolved that as a matter of policy all proposals having financial implications have to be placed as an agenda item before the Finance Committee".

Agenda Item No. BoG 16.04: To consider the inclusion of purchase of personal computer under CPDA

Resolution: After considering all aspects BoG approved the purchase of personal Computers(Desktop) for faculty members upto an AGP of Rs. 7000 under 6th CPC & corresponding level in 7th CPC norms, once in 5 years, as per AICTE norms from Grants-in-Aid funds provided by the ministry. For the faculty members having AGP of Rs. 8000 and above in 6th CPC & corresponding level in 7th CPC norms, purchase of laptop/notebook is allowed subject to the provisions of OM no. F. no. 08(34)/2017-E.II(A) dated 20.02.2018. However, in the case of laptop after using the device for 5 years concerned faculty member(s) may surrender the device or retain it by paying 10% of its cost or as per the applicable DoPT rules at that time (for laptop).

Agenda Item No. BoG 16.05: To consider recruitment to Non-faculty and Faculty Positions at GKCIET

Resolution: The current sanctioned strength of non faculty is 46. However, as the Current approved faculty strength at GKCIET is 31, a total of 35 non-faculty posts (at a 1:1.1 ratio of Faculty to non-faculty posts) are allowed to be recruited, only after the approval of MHRD is accorded to the Recruitment Rules of GKCIET. Director, GKCIET is authorized to take up the recruitment process accordingly and preferably recruit officer level posts in the vacant non-faculty posts available out of 35.The aspect of additional non faculty recruitment beyond 35 will be considered when the sanctioned strength of faculty is increased from 31 so that 1:1.1 parity is ensured.

Agenda Item No. BoG 16.06: To consider Starting of B. Tech Program in Civil
Engineering (CE) and Computer Science & Engineering
(CSE) Department from the session 2020-2021.

Resolution: Not Approved, in view of the poor admissions of students in current B.Tech courses at GKCIET during 2019-20 and considering the overall scenario in the country in Engineering education with respect to the availability of more number of seats than students taking admission.
