## NOTIFICATION FOR 2<sup>ND</sup> ROUND OF DECENTRALIZED COUNSELLING FOR ADMISSION IN THE VACANT SEATS OF 4-YEAR B. TECH PROGRAMS

With reference to the Notification issued by the Department of Higher Education, Govt. of West Bengal vide No. 425-Edu (T)/10M-86/15 dated 19.09.2023 and with approval of the Competent Authority of Ghani Khan Choudhury Institute of Engineering and Technology (GKCIET), the Institute would like to invite applications from all interested candidates for appearing in the decentralized counseling for few vacant seats of **1<sup>st</sup> Year B. Tech** in the following programs: (1) Electrical Engineering, (2) Food Technology, (3) Mechanical Engineering, (4) Civil and Environmental Engineering, (5) Computer Science and Engineering (Artificial Intelligence and Machine Learning). Decentralized Admission is open for all WBJEE/JEE-Mains rank holders. All these B.Tech programs are affiliated to Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal.

		Admission criteria as per WBJEE-2023/ JEE-Mains CSAB-2023/MAKAUT guidelines. All candidates are requested to follow the institute website ( <a href="https://www.gkci.ac.in/notice/admission">https://www.gkci.ac.in/notice/admission</a> ) regarding document requirement, admission procedure and fee structure.

- Allotment and reservations in all of the above vacant seats will be done following Govt. orders, strictly based on merit. **WBJEE/JEE-Mains rank holders will be admitted only as per WBJEE 2023 counseling criteria or JoSAA/CSAB 2023 counseling criteria as the case may be. For WBJEE vacant seats, West Bengal-domiciled candidates will be given preference. For JEE-Mains vacant seats, both WB-domiciled as well as outside candidates are eligible, provided they have a valid JEE-Mains rank and fulfil JoSAA/CSAB-2023 criteria.**
- The candidates must visit the Academic Office physically on **06-10-2023 on/before 1:00 PM** with relevant documents. Tokens will be issued till 1:00 PM; then Merit List will be prepared as per WBJEE-2023/JEE-Mains ranks. Finally, admissions will be as per WBJEE-2023/JEE-Mains 2023 (JoSAA/CSAB) criteria.
- Candidates who are already admitted in GKCIET through centralized WBJEE-2023/JoSAA-2023/CSAB-2023 and 1<sup>st</sup> Round Decentralized Counseling will not be eligible to participate.
