NOTIFICATION FOR DECENTRALIZED COUNSELLING FOR LATERAL ENTRY/ADMISSION IN THE VACANT SEATS OF B. TECH PROGRAMS

With reference to the Notification issued by the Department of Higher Education, Govt. of West Bengal vide No. 526-Edn(T)/10M-51/15 dated 05.12.2023 and with approval of the Competent Authority of Ghani Khan Choudhury Institute of Engineering and Technology (GKCIET), the Institute would like to invite applications from all the interested candidates for appearing in the decentralized counselling for lateral entry against the vacant seats of B. Tech programs. The vacant seats are in the following departments: (1) Electrical Engineering, (2) Food Technology and (3) Mechanical Engineering, all programs being affiliated to Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal.
