# Agenda Item No. FC 21.02: To consider the action taken report on the minutes of the 20<sup>th</sup> Finance Committee of GKCIET, Malda held on 12.10.2023 at 10.30 AM.

#### Agenda Item No. FC 21.03: To consider Budget Estimate 2024-25

**Resolution:** After a brief discussion, in view of ongoing construction activities in the Institute, FC advised to seek more funds than the projected amount of Rs. 15 Cr under OH-35 (GIA for creation of capital assets) and resubmit the budget estimates for 2024-25 to the ministry soon.

### Agenda Item No. FC 21.04: To consider the revised DPR for Centre of Excellence (CoE) in AE and FPT

**Resolution:** The Minutes of the meeting of expert committee constituted, along with revised DPR was placed before the committee. Director has briefed the background of this item and that this is also included as agenda item for the 31<sup>st</sup> Meeting of BoG to be held soon after the conclusion of FC meeting and requested for permission to get a presentation of the DPR of COE made in the BoG meeting to avoid repetition. This request was made as both expert members of the FC were already invited to attend the 31<sup>st</sup> meeting of the BoG also.

### Agenda Item No. FC 21.05: To consider the Draft MoU between GKCIET & MoE for 2024-25 approved by Chairman BoG for ratification.

Resolution: - After brief discussion, The FC ratified the draft MoU approved by Chairman, FC & BoG, along with advice from Shri M M Singh to incorporate certain other aspects on NEP-2020 implementation, initiatives for skill development and other initiatives including the plan of action for reducing instances of suicide, analysis of parliament questions during the previous year etc., {which are likely to be communicated by the ministry soon after this meeting is over} and submit the MoU to the ministry.

## Agenda Item No. FC 21.06: To consider the Grant of Service Benefit to Shri U. C Prasad, Registrar.

**Resolution:** Mr. Umesh C Prasad left the meeting as this item pertains to his service benefits. After a threadbare discussion, the FC resolved to seek advice of the C & AG. Kolkata on the aspect of grant of service benefit to Shri U C Prasad, including that of pay protection as he is not holding any substantive post elsewhere and that the post of Registrar at GKCIET is a Contract/Deputation post.
