#### 4. APPLICATION FEE

- I. An application fee of Rs. 1000/- per candidates belonging to general category/OBC/EWS, whereas Rs. 500/- per candidate belong to SC/ST category is applicable. There is no application fee for the candidates applying under PWD category.
- II. The candidates must pay the application fee through online mode only (NEFT/IMPS/Google pay).

#### 5. ELIGIBILITY CRITERIA/QUALIFICATION (GET-2025)

- I. Must be an Indian Citizen and medically fit. Candidate must be a resident of other states excluding West Bengal & need to be submitted a residential certificate as per standard format.
- II. The minimum qualification for admission to the Diploma Programs is Matric (10th Std.) pass or its equivalent examination from a State Secondary Education Board/CBSE/ICSE/National Open School or equivalent (Please follow the WBSCTE council at https://scvtwb.in/). The candidates appeared/appearing in secondary or equivalent examination in 2025 may also apply and should produce the marks sheet and certificate at the time of counselling, failing which candidature will be cancelled.
- III. Should not be born after 01/07/2010 and there is no upper age limit.

#### 6. APPLICATION PROCEDURE

- I. Before applying for admission, make sure you have an active email id and working contact number/WhatsApp number.
- II. Visit the application portal by clicking the 'Online Application Form' button or go to the following link https://admission.gkciet.ac.in
- III. Candidates need to first register themselves in the portal. Register your new application form using a valid Email ID and mobile number.
- IV. After registering, log in to your account using your Email ID and password.
- V. After login apply for the diploma course.
